Reports and Minutes

Take Action:

- Concern on Reproductive Rights has been laid down for the time being as there did not seem to be unity in our approach.
- Cece and Robin are working on the very important issue of Tampa Friends concerns about LGBTQ issues in Florida, but need help and input to move forward in the form of ideas and direction. Please reach out to Cece if you'd like to help.
- The clerk sent a letter to Equality Florida including a donation by a Friend we asked to be contacted about future plans.
- Worship on Potluck First Days while it is a gift to be able to meet via Zoom each week for worship, there is a strong desire to bring those who are able to the Meetinghouse one First Day a month. This will be on Potluck First Days so that there are multiple events on the day that some people may make the trip to a live worship. While the Zoom link will remain active on those weeks, the

Meetinghouse will not join in, and it will need to be hosted and clerked by someone online. This entails making sure folks are muted or unmuted appropriately and removing any potential Zoom-bombers. We encourage those who can to come to the Meetinghouse, but are leaving the option available for online worship for those who cannot make the trip.

- The Friday newsletter will be combined with the weekly email once the two email lists are reconciled so that folks only get a single email each week.
- The Meeting's website will be transitioned to a less full-functioned website that is more informational rather than interactive to simplify the maintenance process.
- A Google Phone number has been set up for Tampa Quakers 813.575.0313. It can be activated at any time and can be sent to any individual(s). Some expressed concerns about privacy and dealing with sensitive and/or ranting calls, but there are not many calls and this will be a learning experience. It's a good idea to transition to this type of voicemail so that it can easily be transferred to someone who is able to call back in a timely fashion at different times during the year.

Nominating: this is still in progress.

Treasurer's report: Chris reported a \$1,000 memorial gift in memory of David Nicholson. Donations are up during October compared to the immediate previous months. With this increase, we are much more in line with where donations need to be for the year. Friends accepted the Treasurer's report.

Property: Chris Hugues reported that we need to address the termite damage in the front door of the front building. He is also checking out the eaves in the back building where there is some minor damage. The AA group is reducing their presence to 2 days a week due to reduced attendance since COVID made ZOOM meetings a possibility. The UCC church is very interested in using the meetinghouse, but now would like to meet every week. This presents a bit of a problem as it will restrict our use of the building for after meeting events. Conversation/negotiations are continuing.

Learning: Due to a large number of events scheduled for January AFDP will tentatively resume in February.

Community: We having after-meeting snacks and fellowship each First Day along with monthly Potlucks on the 3rd First day of each month. In lieu of a January Friendly Dinner, we encourage Friends to attend the January 1 CommUnity Potluck Gathering at Rowlett Park.

Treasurer's Reports: Donations were lower than expected in November, leaving us with a Prorated Income through November of \$15,135.51, a deficit of \$1,132 through the fiscal year to date. Expenses through November (2Q Fiscal Year) were \$18,721 with the primary contributors being the mortgage (\$7,932.50), insurance (\$4,975.85), lawn maintenance (\$3,450), and electricity (\$1,429.56).
